The undersigned parent or guardian hereby acknowledges that any time before **6:25** p.m. or after **8:30** p.m. in the case of Sparrows, Doves and Eagles clubs are unsupervised and that the Dover First Baptist Church Awasa Clubs do not provide, warrant, or assume any responsibility for such supervision.

The undersigned parent or guardian also acknowledges and agrees that in allowing his /her child to attend Awasa Clubs that said parent or guardian understands that each Awasa Clubber is expected to adhere to and obey all rules of conduct. Also, in order to maintain safety and order and further agrees to allow any club leader to discipline such child, if necessary, when conduct is not satisfactory or in keeping with Awasa Club rules. Discipline incorporates siting in a time out chair after a clubber receives a three count for conduct or not obeying rules. Failures to behave will result in parents having to stay with their child during club, or suspension from club or club activities for any period of time. Parent also agrees to hold the Dover First Baptist Awasa Club; its officers, leaders, directors, or members harmless from any liability if discipline becomes necessary. (Time out chair)
